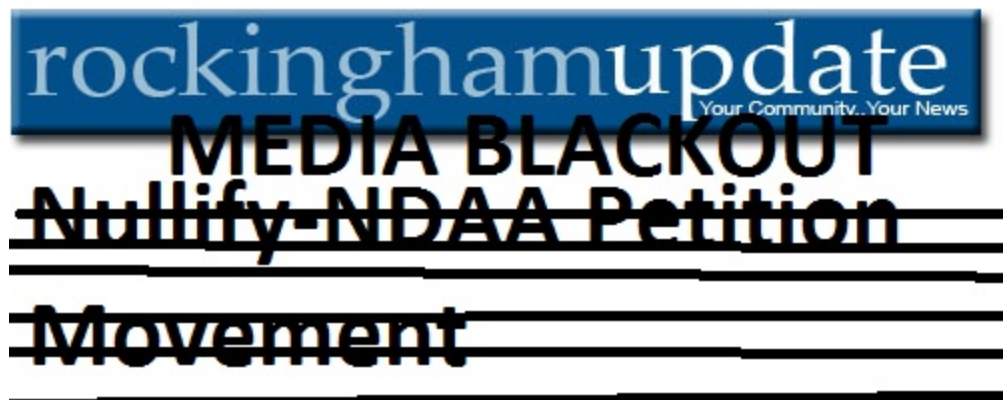

and 2013 resistance in Rockingham County, even when Rep. Bryan R. Holloway a representative for Rockingham County has agreed to oppose the NDAA by voting in favor of NC H.R. 982. If this media blackout continues then USWGO will be forced to compete against RCENO.com by offering a Rockingham County news section on the website which will not blackout any news from Rockingham County residents.

There are plenty of reasons why RockinghamUpdate should consider writing an article about Nullify-NDAA:

1. Nullify-NDAA signatures were collected only within the boundaries of Rockingham County.

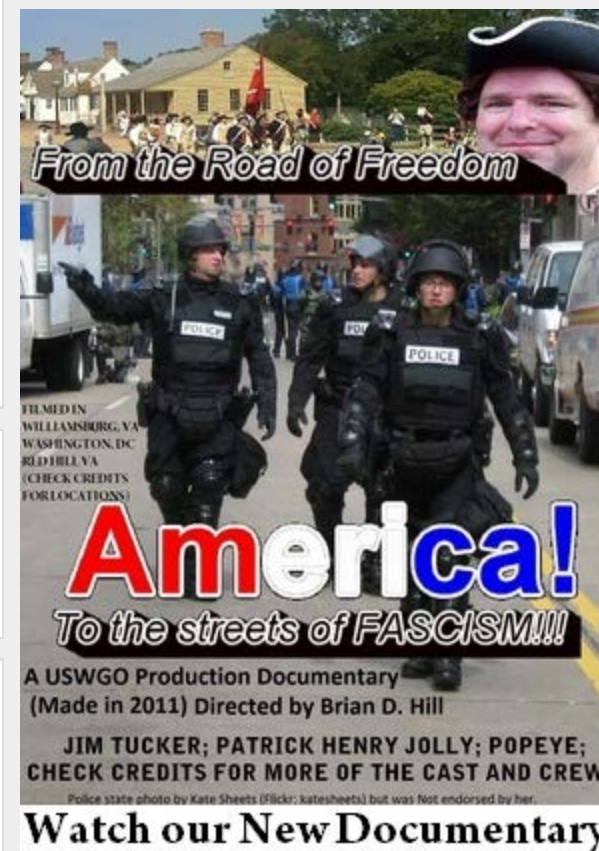

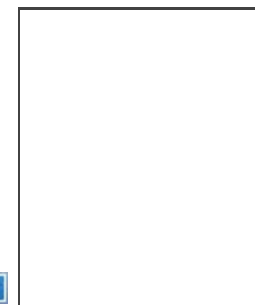
